In accordance with the showing made to this Division, pursuant to RCW 83.24.010, we hereby find that the property not probated in the above estate, as disclosed by said showing, is not subject to inheritance tax in this state, said property being described as follows:

Real property situated in Skamania County, State of Washington, to-wit:

The Southwest quarter of the Northwest quarter of Section 28, Township 3 North of Range 8 East of the Willamette Meridian; the Southeast quarter of the Northwest quarter of said Section 28, excepting therefrom a tract in the Northwest corner thereof 40 rods wide from East to West and 32 rods long from North to South, heretofore deed by grantor to J. A. Laubach by deed dated April 13, 1900, and filed for record on said date and recorded in Book "P" of Deeds, page 595, records of the auditor of said Skamania County, Washington, and excepting therefrom a tract in the Northeast corner thereof 38 rods wide from East to West and 63½ rods long, from North to South, heretofore deeded by grantor and Florentine Zurcher, his wife, to George Monner, by deed dated April 21, 1916; filed for record, April 22, 1916, and recorded in Book "P" of Deeds, page 515, records of the auditor of said Skamania County, Washington.

A strip of land 2 rods wide, excepted from the deed from grantor to Robert Jones, and described as beginning at a point 40 rods East from the Southwest corner of the Northeast quarter of the Northwest quarter of said Section 28, Township 3 North of Range 8 East of the Willamette Meridian, running thence North 80 rods; thence East 2 rods, thence South 80 rods; thence West 2 rods to the point of beginning.

A strip of land one rod wide, described as beginning at the Northeast corner of the Southeast quarter of the Northeast quarter of Section 29, Township 3 North, Range 8 East of the Willamette Meridian, running thence 80 rods West on the North line of the Southeast quarter of the Northeast quarter of said Section, to the Northwest corner of the Southeast quarter of the Northeast quarter of aforesaid section; thence South 1 rod; thence East 80 rods, running parallel with first described line to the East line of said section 29; thence North 1 rod to place of beginning.

A tract of land described as beginning at a point 418 feet East of the Southwest corner of the Northeast quarter of the Northeast quarter of Section 29, Township 3 North of Range 8 East of the Willamette Meridian, running thence East 209 feet; thence North 104.5 feet; thence West 209 feet; thence South 104.5 feet, to the point of beginning.
