Beginning at a point on the East line of said Section 33 which is 700 feet South of the Northeast corner of the Southeast quarter of the Northeast quarter of said Section; thence West 200 feet; thence South parallel to the East line of said Section 300 feet, more or less, to the center of the Washougal River; thence Easterly and upstream along the center of said river 200 feet, more or less, to the East line of said Section 33; thence North along the East line of said Section 300 feet, more or less, to the point of beginning.

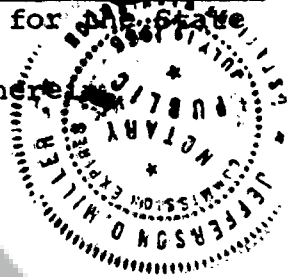

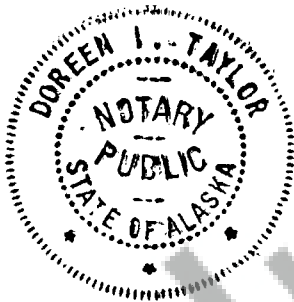

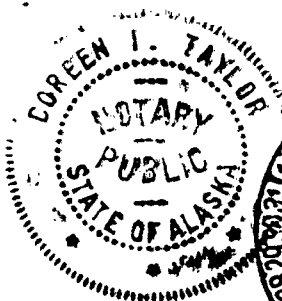
