## CENTERLINE DESCRIPTION

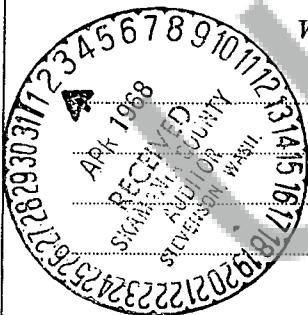
Beginning at P.O.C. Station 5 + 96.19 which lies 65 feet West from the Northwest corner of the Henry Shepard D.L.C. No. 43; Thence following a 9° 00' curve to the left 57.59 feet to Station 6 + 53.78, being the P.T. of said curve; thence N 15° 07' W 107.57 feet to Station 7 + 61.35 being the P.C. of a 8° 00' curve to the left; thence following said 8° 00' curve 116.46 feet; thence N 24° 26' W 256.33 feet to Station 11 + 34.14 being the P.C. of a 23° 00' curve to the right; thence following said 23° 00' curve 250.00 feet; thence N 33° 04' E 181.81 feet to Station 15 + 65.95, being the P.C. of a 10° 00' curve to the left; thence following said curve 148 feet more or less to the North line of Government Lot 2 of Section 36, Township 3 North, Range 7 E.W.M.

## RIGHT OF WAY DESCRIPTION

A strip of land lying Easterly from above described centerline and Westerly from a line drawn parallel to and 30 feet distant right from said centerline from approximate Station 7 + 50 to Station 11 + 00; thence to a point 70 feet distant right when measured radially at Station 12 + 50; thence to a point 30 feet distant right when measured perpendicular at Station 14 + 50; thence parallel to and 30 feet distant right when measured perpendicular and/or radially from described centerline from Station 14 + 50 to approximate Station 17 + 14 being the North line of Govt. Lot 2, Sec. 36, T. 3 N., R. 7 E.W.M. Excepting existing Right of Way situated in the County of SKAMANIA, State of Washington. Contains 0.42 acres more or less, 1968.
