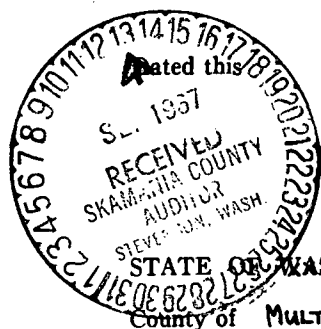
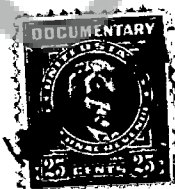
in hand paid, conveys and warrants to ROBERT F. GEORGE and JEWELL E. GEORGE, husband and wife,

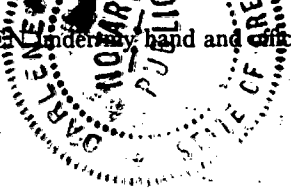
