## REAL ESTATE CONTRACT

For Unimproved Property

THIS CONTRACT, made this 5th . day of July, 1968,

between

E. R. SOOTER and RUBY SOOTER, husband and wife,

hereinafter called the "seller" and

WILLIS G. GREEN and MARILYN J. GREEN, husband and wife,

hereinafter called the "purchaser,"

WITNESSETH: The seller agrees to sell to the purchaser, and the purchaser agrees to purchase of the

EXCEPTING AND RESERVING to the sellers, their heirs and assigns the existing water pipeline owned by E. R. Sooter and Henry J. Zilka.

On the following terms and conditions: The purchase price is ONE THOUSAND and NO/100 - - - (\$ 1,000.60) ) dollars, of which TWO HUNDRED FIFTY and NO/100 - - - - - - - (\$ 250.00) ) dollars has been paid, the receipt whereof is hereby acknowledged, and the purchaser agrees to pay the balance of said purchase price as follows:

The purchasers agree to pay the remaining balance of the purchase price amounting to Seven Hundred Fifty and No/100 (\$750.00) Dollars in quarterly installments of One Hundred Eighty-Seven and 50/100 (\$187.50) Dollars, or more, on the fifth day of October, 1968, on the fifth day of January, 1969, on the fifth day of April, 1969, and on the fifth day of July, 1969. In addition to the quarterly installments of the purchase price aforesaid the purchasers agree to pay interest from the date of this contract at the rate of five per-cent (5%) per annum computed on the diminishing principal basis, which interest shall be due and payable on the aforesaid quarterly installment dates.
