#### CENTERLINE DESCRIPTION

Beginning at a point on the East line of Section 27, Township 4 North, Range 7 E.W.M., said point lying S 0° 12' W. 1069.59 feet from the Northeast corner of said Section 27, said point of beginning being Engineers Station 38 + 65.64; Thence S 76° 58' W 299.64 feet to Station 41 + 65.28 being the P.C. of a 1° 00' curve to the left; Thence following said curve to the left 93.33 feet to the P.T. of said curve, being Station 42 + 58.61; Thence S 76° 02' W 537.75 feet to Station 47 + 96.36, being the P.C. of a 1° 00' curve to the right.

That land lying southerly of and contiguous to the existing right of way and northerly from a line drawn parallel to and 30 feet distant left when measured perpendicular to and/or radially from above described centerline from the East line of Section 27, Township 4 North, Range 7 E.W.M. being Station 38 + 65.64 to the West line of S.E.  $\frac{1}{4}$  of the N.E.  $\frac{1}{4}$  of the N.E.  $\frac{1}{4}$  of said Section 27.

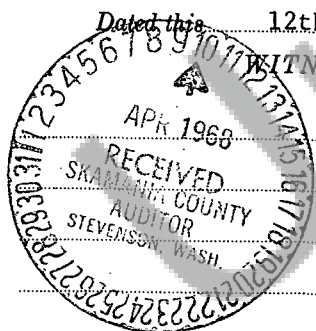
