conveys and quit claims to SKAMANIA COUNTY, WASHINGTON

the following described real estate, situated in the County of SKAMANIA State of Washington,
together with all after acquired title of the grantor(s) therein:

A right of way as required for the relocation of the County Road known and designated Little Buck Creek Road (Co.Rd.No. 3097) located in the S.E. $\frac{1}{4}$ of Section 16, Township 3 North, Range 10 E.W.M. in Skamania County, Washington, being a strip of land to the right and a strip of land to the left from the following described centerline.

CENTERLINE DESCRIPTION

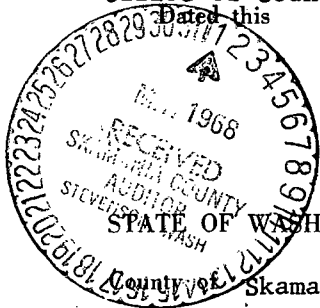
Beginning at P.O.C. Sta. 7 + 00.83, said point lying 1127.8 ft. West from the iron pipe marking the S.E. corner of Section 16, Twp. 3 North, Range 10 E.W.M.; thence following a 12° 00' curve to the left, the long chord of which, bears N 28° 37 $\frac{1}{2}$ ° W, 80.69 ft.; thence N 33° 18' W 394.86 ft. to Sta. 11 + 76.38 being the P.C. of a 20° 00' curve to the right. Thence following said curve 296.92 ft.; thence N 26° 05' E 243.32 ft. to Sta. 17 + 16.62, being the P.C. of a 12° 00' curve to the left; thence N 0° 38' W 240 ft. more or less to the North line of the S $\frac{1}{2}$ of the S.E. $\frac{1}{4}$ of Section 16, Twp. 3 North, Range 10 E.W.M.

RIGHT OF WAY DESCRIPTION

A strip of land lying between the above described centerline and a line drawn: parallel to and 40 ft. distant left from centerline from Sta. 7 + 00.83 to the North line of the S. $\frac{1}{2}$ of the S.W. $\frac{1}{4}$ of S.E. $\frac{1}{4}$ of Sec. 16; Thence along said North line to a point 30 ft. distant from described centerline; thence parallel to and 30 ft. distant from said centerline to the North line of the S $\frac{1}{2}$ of S.E. $\frac{1}{4}$ of said Sec. 16.

Also a strip of land lying between the above described centerline and a line drawn: parallel to and 30 ft. distant right from said centerline from Sta. 7 + 00.83 to Sta. 11 + 50; thence in a straight line to a point 30 ft. distant right from Sta. 15 + 00; thence parallel to and 30 ft. distant right from said centerline to the North line of S $\frac{1}{2}$ of S.E. $\frac{1}{4}$ of Section 16.

All as shown on the Little Buck Creek Road pland dated March, 1968 and on file in the Office of County Engineer. Excepting existing right of way. Contains, 0.29 acres more or less.

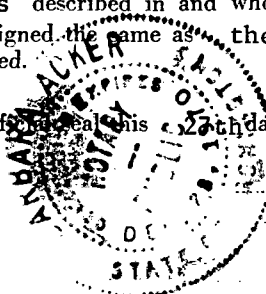
