A tract of land located in Government Lot 1 of Section 34, Township 2 North, Range 6 E. W. M., described as follows:

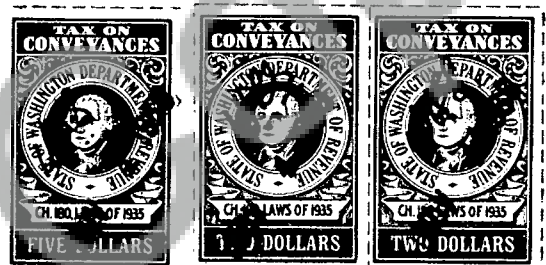

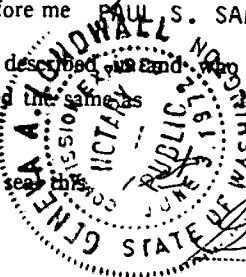

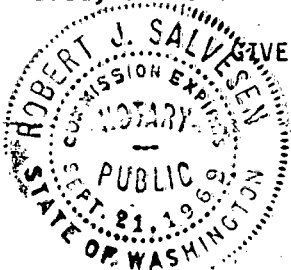
