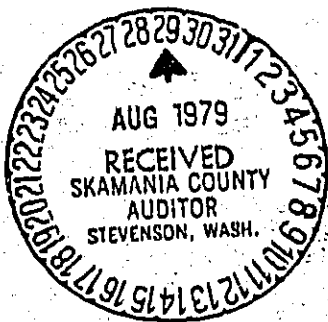


CONSENT TO USE ROAD

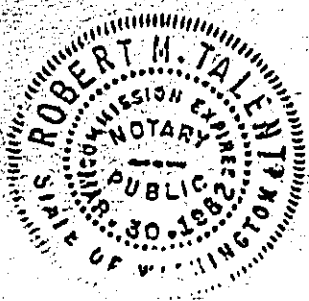
