DISSOLUTION OF PARTNERSHIP AGREEMENT

THIS AGREEMENT made and entered into this 4th day of October, 1978 by and between JOHN L. GARMOOD, hereinafter referred to as FIRST PARTY, residing at P. O. WITNESSETH:

WHEREAS a partnership now exists between the above men-Moned parties engaged in the business of gasoline service station and automobile repair garage in Stevenson, Washington under the firm name and style "UNION 76 GARAGE",

AND WHEREAS a further continuance of the partnership is no longer mutually desired and the parties, by mutual consent, have agreed to a dissolution of said partnership,

NOW THEREFORE, it is hereby agreed by and between the parties that in consideration of the mutual agreement to dissolve said partnership the First Party herein conveys, transfers, assigns and sells all (of his right, title, and interest in and to that business of the firm of Union 76 Garage doing business at Stewnson, washington including but not limited to all stock, fixtures, washington including but not limited to all stock, fixtures, accounts, inventory and assets of every nature, kind and description whatsoever including the lease hold interests as hereinafter, tion whatsoever including the lease hold interests as hereinafter, set forth to have and to hold said goods, chattels and interest unto Second Party, his heirs, executors and assigns and for his own purpose and use forever.

It is furthe agreed that the partnership heretofora existing to waen First and

Second Party under the firm name and style of UNION 76 GARAGE is hereby dissolved and ended and that Second Party shall become the sole owner of all right, title and interest therein said assets aforementioned belonging to said partnership and Second Party agrees to assume all outstanding leases, agreements and contracts of the partnership.

Second Party shall continue to be authorized to use his name in the style of said firm and First Party herein agrees that he shall not, for a period of ten (10) years, engage in the business of a gasoline service station examples of a partnership or otherwise, DATED this 4th day of October, 1978.
