## ASSIGNMENT OF LEASE

KNOW ALL MEN BY THESE PRESENTS, That Jacqueline J. Roddewig Assignor, for value received hereby assigns unto Jane Meyer, Evelyn M. Carrow and Jacqueline J. Cabin site number 162 of the North Woods as shown in red on Exhibit "A" attached hereto (all distances being approximations), being part of Government Lots 4 and 8, Section 26, Township 7 North, Range 6 East, W.M., Skamania County, Washington, SUBJECT, however to an easement for right of way for access road acquired by the United States of America, United States Forest Service.

and to Hold the same unto said Assignee and assigns from September 28, 1976, the rest of the term of said lease, subject to the covenants, conditions and provisions therein mentioned. The rents provided for in said lease are paid to and including August 31, 1980.

AND the Assignor hereby covenants that the interest in said lease hereby assigned is free from encumbrances.

In construing this assignment and where the context so requires, the singular includes the plural and all grammatical changes shall be implied to make the provisions hereof apply equally to corporations and to individuals.
