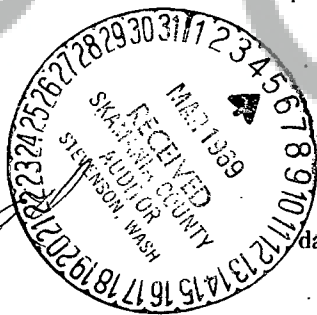

Washington: A tract of land located in the South Half of the Southeast Quarter
(S 1/2 SE 1/4) of Section 26, Township 2 North, Range 5 E.W.M., described
as follows:

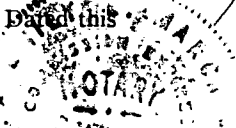
Beginning at a point on the south line of the said Section 26 west 750 feet from the southeast corner of the said Section 26; thence north 13°30' east 350 feet to an iron pipe, said point being the initial point of the tract hereby described; thence north 13°30' east to the southerly boundary of the 300 foot strip of land acquired by the United States of America for the Bonneville Power Administration's electric power transmission lines; thence westerly following the southerly boundary of said strip of land to the easterly right of way line of the county road known and designated as the McCloskey Creek Road; thence in a southwesterly direction following the easterly right of way line of said road to a point 600 feet distant, measured along the easterly right of way line of said road, from the south line of the said Section 26; thence in a southeasterly direction 890 feet, more or less, to the initial point.
