PURCHASER'S ASSIGNMENT OF CONTRACT AND DEED

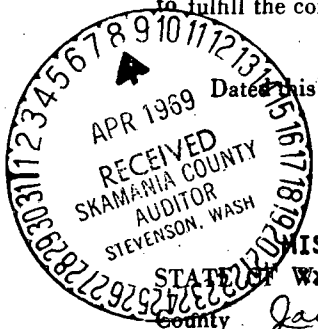
THE GRANTOR S **LLOYD E. FLOOD and CAROL SUE FLOOD, husband and wife,**

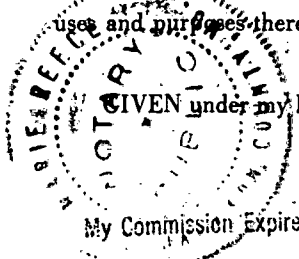
