EASEMENT

The Grantor, Jewell D. Van Matre of Goldendale, Washington for and in consideration of One Dollar (\$1.00) and other valuable consideration, in hand paid, receipt of which is hereby acknowledged, grants and conveys to the State of Washington, acting by and through its Department of Natural Resources, Grantee, its successors and assigns, an easement for road right of way forty (40) feet in width over and across the following described lands in Skamania County, Washington, to wit:

Sh NW4 NW4 of Section 28, Township 2 North, Range 6 East, W.M. and Sh NE4 NE4 of Section 29, Township 2 North, Range 6 East, W.M.

as shown on the plat marked Exhibit A, which is attached hereto and by this reference made a part hereof.

The easement granted herein is subject to the following terms and conditions:

- 1. The road to be constructed and/or maintained on the said right of way shall be used for access to lands presently or in the future owned or controlled by the Grantee for land management and administration activities, including but not limited to valuable material removal operations, and for public access to such lands for recreational purposes under such rules, regulations and limitations as may be established by Grantee.
- 2. The Grantor reserves to itself, its successors and assigns, the right to use, at its own risk, the roadway in any manner which does not unreasonably interfere with the use of said road by the Grantee, its successors and assigns, agents, contractors, employees, or licensees, or the public when on said road in conformity with the rules, regulations, and limitations referred to in Condition 1 above. Said road users will, except the public, contribute their pro rata share to the maintenance costs caused by their usage so that such maintenance will leave the road in as good condition as it existed at the time of commencement of said use.
- 3. Grantee agrees to establish common south and west property lines of NE NE of Section 29, Township 2 North, Range 6 East, W.M., in lieu of \$100.00 cash payment. Said property lines to be established by July 1, 1969.
