Consisting of a total acreage of 0.10 acres less rights previously acquired by Skamania County.

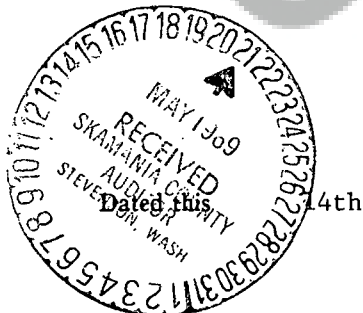

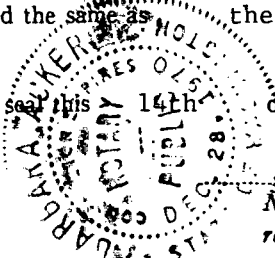
