REAL ESTATE CONTRACT

For Unimproved Property

THIS CONTRACT, made this 22nd day of

May, 1969,

between

HOWARD ESTEY and VERA ESTEY, husband and wife,

hereinafter called the "seller" and

BROUGHTON LUMBER CO., a Washington corporation,

hereinafter called the "purchaser,"

WITNESSETH: The seller agrees to sell to the purchaser, and the purchaser agrees to purchase of the

seller the following described real estate with the appurtenances, situate in

Skamania

County.

Washington:

The Northeast Quarter of the Southeast Quarter (NE4 SE4), and the South Half of the Southeast Quarter (S12 SE14), of Section 13, Township 3 North, Range 9 E. W. M.; and

The East Half of the Northeast Quarter (E1/2 NE1/4) of Section 24, Township 3 North; Range 9 E. W. M.

Free of incumbrances, except:

TOGETHER WITH the right first to refuse the sale by the sellers of any portion or all of the adjoining real property owned by them in Sections 24 and 25, Township 3 North, Range 9 E. W. M.

On the following terms and conditions: The purchase price is One Hundred Thousand and no/100 (\$ 100,000.00) dollars, of which Ten Thousand and no/100 -(\$ 10,000.00) dollars has been paid, the receipt whereof is hereby acknowledged, and the purchaser agrees to pay the balance of said purchase price as follows:

The purchaser agrees to pay the balance of the purchase price in the sum of Ninety Thousand and no/100 (\$90,000.00) Dollars as follows:

The sum of Thirty Thousand and no/100 (\$30,000.00) Dollars on January 1, 1970; the further sum of Thirty Thousand and no/100 (\$30,000.00) Dollars on January 1, 1971; and the remaining balance of the purchase price lamounting to Thirty Thousand and no/100 (\$30,000.00) Dollars on January 1, 1972. The unpaid purchase price shall bear interest at the rate of six, per cent (6%) per annum payable annually on the installment dates herein specified, and computed upon the diminishing principal basis.

The purchaser may enter into possession May 22, 1969.

The property has been carefully inspected by the purchaser, and no agreements or representations pertaining thereto, or to this transaction, have been made, save such as are stated herein.

The purchaser agrees: to pay before delinquency all taxes and assessments assumed by him, if any, and any which may, as between grantor and grantee, hereafter become a lien on the premises; not to permit waste; and not to use the premises for any illegal purpose. If the purchaser shall fail to pay before delinquency any such taxes or assessments, the seller may pay them, and the amounts so paid shall be deemed part of the purchase price and be payable forthwith with interest at the rate of ten per cent per annum until paid, without prejudice to any other right of the seller by reason of such failure.

The purchaser assumes all risk of the taking of any part of the property for a public use, and agrees that any such taking shall not constitute a failure of consideration, but all moneys received by the seller by reason thereof shall be applied as a payment on account of the purchase price, less any sums which the seller may be required to expend in procuring such moneys.

If seller's title to said real estate is subject to an existing contract or contracts under which seller is purchasing said real estate, or any mortgage or other obligation, which seller is to pay, seller agrees to make such payments in accordance with the terms thereof, and upon default, the purchaser shall have the right to make any payments necessary to remove the default, and any payments so made shall be applied to the payments next falling due the seller under this contract.

The seller agrees, upon full compliance by the purchaser with his agreements herein, to execute and
