Beginning at the intersection of the northerly shore of Greenleaf Slough with the easterly line of said Hamilton D. L. C.; thence south 17° 30' east following the easterly line of said D. L. C. to intersection with the northerly right of way line of Primary State Highway No. 8; thence westerly along the northerly line of said highway 240 feet; thence north 17° 30' west parallel to the easterly line of said D.
