THIS MATTER coming on regularly to be heard this 20th day of August, 1969, upon the Final Report and Petition for Distribution, Thelma G. Marker, Administratrix, being present and being represented by her attorney, Howard Carothers, and it appearing that notice of said hearing was duly published in the manner required by law, and evidence having been presented in support of said report and petition, and there being no objection thereto, the Court FINDS:

That the above named decedent, Edward W. Bruning, died intestate at Tacoma, Washington, on the 19th day of September, 1967; that
he was a resident of Pierce County and owned property therein and in
Skamania County, Washington, at the time of his death; that on the 11th
day of March, 1969, Thelma G. Marker was duly appointed and qualified
as administratrix of the estate of said decedent.

That Notice to Creditors was published in the manner and for the time required by law; that more than four months have elapsed between the first publication of said notice and the date of the filing of the Final Report herein; that no creditors claims have been filed or served herein.

That said decedent was a widower at the time of his death and left surviving him as his sole heir his daughter Thelma G. Marker; that he left surviving him no other child or issue of a deceased child and his said daughter became entitled to inherit his entire estate.

That there are no funeral or burial expenses or other obligations of any kind owing by said estate other than expenses of administration; that there is no inheritance tax owing the State of Washington and no estate or other tax owing the United States; that the sum of \$\frac{335.00}{25.00}\$ is a reasonable sum to be allowed Howard Carothers for legal services rendered as attorney herein; NOW, THEREFORE,

IT IS HEREBY ORDERED, ADJUDGED AND DECREED AS FOLLOWS:

- 1. That the Final Report of the Administratrix filed herein be and is in all respects approved.
- 2. That the sum of \$335.00 is hereby allowed Howard Carothers for legal services rendered as attorney for the Administratrix herein.
- 3. That there be and is hereby distributed and set over to Thelma G. Marker, daughter and sole heir of said decedent, all assets belonging to said estate consisting of the following:

A tract of land located in the Northwest Quarter of the Southeast Quarter (NW4 SE4) of Section 25, Township 3 North, Range 7 E. W.M., Skamania County, Washington, described as follows: Beginning at the southwest corner of the NW4 of the SE4 of the said Section 25; thence east to the county road known and designated as the Kanaka Creek Road; thence northerly along said road 250 feet;


