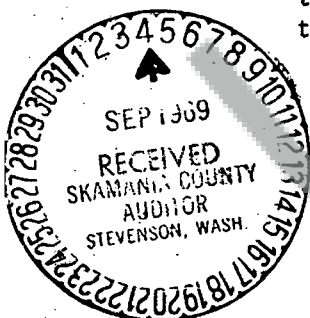
in hand paid, conveys and warrants to ALMA M. GRAHAM
