in hand paid, conveys and warrants to JAMES E. TURNER and CHERINE B. TURNER, husband and wife,

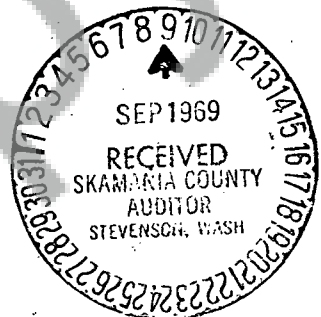
the following described real estate, situated in the County of SKAMANIA, State of Washington:
