This being a gift deed and no monetary consideration being involved, no transaction tax is payable and no revenue stamps are required.

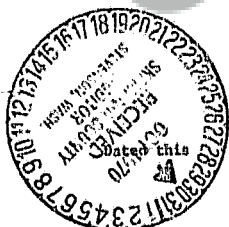

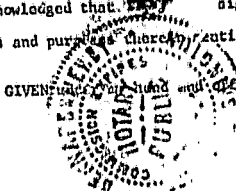
