

## REAL ESTATE CONTRACT

(FORM A-1954)

THIS CONTRANT, made and entered into this 29th day of Octobor, 1970

EXCEPT Oil, gases, coal, ores, minerals and fossils and rights of way for the removal of timber, minerals, sand and gravel reserved by the State of Washington in deed dated June 8,1945. and recorded April 15,1947, page 341, of Book 31 of Jeeds, Records of Skazenia County, Machington;

AND SUBJECT TO easements for and rights of way reserved by the State of Washington for Primary State Highway No 8.

TOGERHER WITH easement for right of way over and across the SEA of NWA of said section IC.

The terms and conditions of this contract are as follows: The purchase price is
