EASEMENT

The easement granted herein is subject to the following terms and conditions:

- 1. The read to be constructed and/or maintained on the said right of way shall te used for access to lands presently or in the future owned or controlled by the Grantee for land management and administration activities, ing but not limited to valuable material removal operations, and for paties access to such lands for recreational purposes under such rules, regulations, and it and limitations as may be established by Grantee.
- 2. The Grantor reserves to itself, its successors and assigns, the right to use, at its own misk, the roadway in any manner which does not unreasonably interfere with the use of said road by the Grantee, its successors and assigns, agents, contractors, employees, or licensees, or the public when on said road in conformity with the rules, regulations, and limitations referred to in Condition 1 shows and said road assessed. to in Condition 1 above. Said road users will, except the public, contribute their pro rata share to the maintenance costs caused by their usage so that such maintenance will leave the road in as good condition as it existed at the time of commencement of said use.
- 3. A speed limit of 15 m.p.h. shall be observed by all vehicles using road within 300 feet of the house.
- h. Grantee shall provide adequate dust a nate ent when conditions warrant. Said dust abatement shall be provided for ne more than 300 feet from the house.
- 5. The gate as indicated on Exhibit "A" shall be closed by Grantee after each days use.




