

RIGHT OF WAY EASEMENT

THE GRANTORS, Maynard A. Compher and Lillian Compher, husband and wife,
 Virgil J. Anderson LILLIAN M.D. ANDERSON, husband and wife,
 and Sally¹⁶ T. Jones, husband and wife, of Skamania County, State of Washington,
 for good and valuable consideration, the receipt of which is hereby acknowledged,
 hereby grant to PUBLIC UTILITY DISTRICT NO. 1 of SKAMANIA COUNTY, WASHINGTON, a
 municipal corporation and to its successors and sub-lessee or assigns, the right
 to enter upon the lands of the Grantors situated in the County of Skamania,
 State of Washington, and more particularly described as follows:

An easement 10 feet in width as cleared, staked, and to be constructed in the
 N $\frac{1}{2}$ of the NE $\frac{1}{4}$ of Section 17, T2N Rge 5 EWM, and in the SE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section
 18, T2N, Rge 5 EWM

to construct, operate and maintain over and under the above described lands, and
 the streets, roads, or highways abutting the said lands an electric transmission
 or distribution line or system, with all convenient or necessary appurtenances
 (including but not limited to poles, crossarms, towers, transformers, one or
 more wires, props, guys, and other supports), and to cut and trim trees and
 shrubbery that may interfere with or threaten or endanger the operation and
 maintenance of said line or system.

The Grantors agree that all poles, wires or other facilities installed upon or
 under the above described lands at the Grantee's expense shall remain the property
 of the Grantee, and that the Grantee shall have the right of ingress and egress
 over the adjacent lands of the Grantors for the purpose of exercising the rights
 hereby granted.

The Grantee agrees that installation of facilities shall be limited to underground
 wires and conduit, and only such surface mounted facilities as are necessary to
 the operation of these underground facilities. All rights hereunder shall cease
 when the grantee, its successors and sub-lessee or assigns abandons or removes
 said line or system.

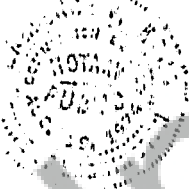

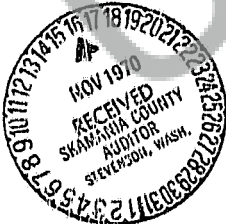
