

## EASEMENT FOR ROAD CROSSING AND QUITCLAIM OF RIGHT OF WATER USE

KNOW ALL MEN BY THESE PRESENTS that we George Jensen and Emma Jensen, husband and wife, the party of the first part, do hereby bargain, give, grant and warrant to Vernon A. Good and Virginia A. Good, their heirs or assigns, the party of the second part, a perpetual road easement across certain tracts or parcels of land, situate, lying and being in the County of Skamania and State of Washington, and more particularly bounded and described as follows, to wit:

Following the Northeast extension of Montell Terrace from Strawberry Hill Tracts in Sec. 35, T 3N, R 7&E, Wm. Mer. to a point at the northernmost road bend within Lot 6, thence following in general the now existing new road route extending Northwesterly around the toe of the hill slope, on a moderate grade, to a point intersecting the pipeline easement clearing both now visible on aerial photograph No. SW-68 708-7, (as shown for the State of Washington, Department of Natural Resources, on June 10, 1968), and continuing thence to the North boundary of Lot 6, for purposes of ingress and egress, including construction and maintenance of said roadway to a width of at least 20 feet.

at and for the agreed consideration being a Quitclaim to a right of water use and a grant of a right of entry from and upon the lands of the party of the second part herewith granted and by this means conveyed to George Jensen and Emma Jensen their heirs or assigns, and more particularly described as follows:

The right to use forty gallon per hour flow of water from a spring rising on a tract of land owned by the party of the second part, described as the SE 1/4 of Lot 2, Sec. 36, T 3N, R 7&E, Wm. Mer., and granting to the party of the first part the right to enter upon said land for the purpose of constructing, maintaining or removing a water intake and buried pipeline across the said lands for the purpose of carrying, and/or diverting said amount of water, but reserving to the party of the second part, their heirs or assigns, the right to the first forty gallon per hour flow of water from said spring, and all additional flow of water exceeding eighty gallons per hour.
