

RIGHT OF WAY EASEMENT

THE GRANTOR(S) John G. Allinger and Dorothy E. Allinger husband and wife

for good and valuable consideration, the receipt of which is hereby acknowledged, hereby grant, warrant and convey to PUBLIC UTILITY DISTRICT NO. 1 OF SKAMANIA COUNTY, WASHINGTON, a municipal corporation, and to its successors and sub-lessee or assigns, the right to enter upon the lands of the Grantor(s) situated in the County of Skamania, State of Washington, and more particularly described by the following easement:

The West ten (10) feet and the North five (5) feet of the following described property: Beginning at a point 60 rods and $10\frac{2}{3}$ feet East and 101 rods $13\frac{1}{2}$ feet North of the Southwest corner of the Northwest quarter of the Southwest quarter (NW $\frac{1}{4}$ SW $\frac{1}{4}$) of Section 21, Township 3 North, Range 8 East of the Willamette Meridian; THENCE East 328.3 feet; North 565 feet; West 328.3 feet; South 565 feet to the point of beginning. All within the Southwest quarter of the Northwest quarter (SW $\frac{1}{4}$ NW $\frac{1}{4}$) of said Section 21. SUBJECT TO easements and rights of way for county roads over and across the above described real property.

SAID easement to include CARSON WATER distribution system.

TRANSACTION EXCISE TAX

To construct, operate and maintain over and under the above described lands, and the streets, roads or highways abutting the said lands, an underground electric transmission or distribution line or system, including wires and conduit, with all convenient or necessary space mounted appurtenances (and to include riser poles and transformer poles where required) and to cut and trim trees and shrubs that may interfere with or endanger the operation and maintenance of said line or system, and to license, permit or otherwise agree to the joint use or occupancy of said line or system by other person, firm or corporation for telephone or television purposes.

The grantor(s) agree(s) that all poles, wires or other facilities installed upon or under the above described lands at the Grantee's expense shall remain the property of the Grantee, and that the Grantee shall have the right of ingress and egress over the adjacent lands of the Grantor(s) for the purpose of exercising the rights hereby granted.

All rights hereunder shall cease when the Grantee, its successors and sub-lessee or assigns abandons or removes said line or system.
