## SCHEDULE "A"

## STEVENSON LUMBER COMPANY, a Corporation to SKAMANIA COUNTY, WASHINGTON

A right of way as required for the construction of the County Road known and designated Iman Loop Road, County Road No. 2386, in Section 35, Township 3 North, Range 7 E.W.M. in Skamania County, Washington more particularly described as follows:

## PROPOSED CENTERLINE DESCRIPTION

Beginning at Station 0 + 00, said point being S 5° 55' W 184.65 feer from the N.E. corner of the S.E. & of the S.E. & of Section 35; thence S 89° 14' W 415.48 feet; thence on a 700 ft. radius curve to the left 515.65 feet to P.T. Station 9 + 31.13; thence S 47° 27' W 174.81 feet; thence on a 500 ft. radius curve to the right 672.79 ft. to P.T. Station 17 + 78.73; thence N 55° 26' 30" W 171.27 feet to Station 19 + 50 being the end of the project.

## RIGHT OF WAY DESCRIPTION

1. A strip of land lying contiguous to the above described centerline. Said land being 80 feet in width, 40 feet right and 40 feet left of said centerline from the East line of the S.W. & of the S.E. & of Section 35 to Station 18 + 00; whence 60 feet in width, 30 feet right and 30 feet left of said centerline to Station 19 + 50.

The described parcel consisting of 0.99 acres more or less.

This document grants the County permission to construct any cut or fill slopes which may exceed the right of way width by not more than 10 feet right or left from the East line of the S.W.\( \frac{1}{2} \) of the S,E.\( \frac{1}{2} \) of Section 35 to Station 15 + 00.
