north 214 feet thereof; AND EXCEPT the east 208 feet thereof.

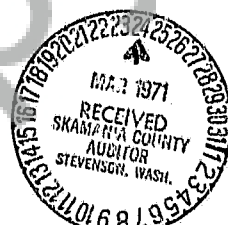

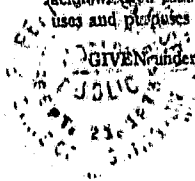
