REAL ESTATE CONTRACT

THIS CONTRACT, made this 15th day of Hay, 1971

FRANK E. VOORNEES and ALICE E. VOORNEES.

hereinafter called the "seller" and

ROBERT T. MASH and MARGUERITE A. NACH,

hereinafter called the "purchaser,"

husband and wife, ...
WITNESSETH: The seller agrees to sell to the purchaser, and the purchaser agrees to purchase of the seller the following described real estate with the appurtenances, situate in Skamania

A tract of land located in Section 26, Township 2 North, Range 6 E. W. H., described as follows:

Beginning at a point 967-27 feet north and 205-75 feet east of the southwest corner of the Southwest Quarter of the Southeast Quarter (SE4 SE4) of the said Section 26; thence north 70° 40' east 300 feat to the initial point of the tract hereby described, said point being on the northerly right of way line of the county read known and designated as Little Street; thence north 19° 20' wast Little Creek to intersection with the northerly right of way line of said county road; thence south 70° 40° west along said right of way line to the initial point.

On the following terms and conditions: The purchase price is Four Thousand Five Hundred and (\$ 4,500.00) dollars, of which) dollars - (\$ h90.00) Four Hundred and no/100ths has been paid, the receipt where. is hereby acknowledged, and the purchaser agrees to 1 40 the balance of said purchase price as follows:

The purchasers agree to pay the balance of the purchase price in the sum of Four Thousand One Hundred and no/100ths (\$4,103.00) Dollars in monthly installments of Fifty and no/100ths (\$50.00) Dollars, or more, commencing on the 1st day of June, 1971, and on the 1st day of each and every month therester until the full amount of the purchase price together with interest shall have been poid. The said monthly installments shall include interest at the ratgof six per-cent (6%) per annum computed upon the monthly balances of the unpaid purchase price, and shall be applied first to interest and then to principal. The purchasers reserve the right at any time they are not in to principal. The purchasers reserve the right at any time they are not pen-default under the terms and conditions of this contract to pay without penalty any part or all of the unpaid purchase price, plus interest then due.

This contract shall not be assigned without the express written consent of the sellers, and any purported assignment thereof without such consent shall be null and void.

The purchaser agrees: (1) to pay before delinquency all payments of whatsoever nature, required to be made upon or by virtue of said mortgage, if any; also all taxes and assessments which are above assumed by him, if any, and all which may, as between grantor and grantee, hereafter become a lien on the premises; and also all taxes which may hereafter be levied or imposed upon, or by reason of, this contract or the obligation thereby evidenced, or any part thereof; (2) to keep the buildings now and hereafter placed upon the premises unceasingly insur ad against loss or damage by fire, to the full insurable value thereof, in the name of the seller was owner, in an insurance company satisfactory to the seller for the benefit of the mortgagee, the seller, and the purchaser, as their interests may appear, until the purchase price is fully paid, and to deliver to seller the insurance policies, renewals, and premium receipts, except such as are required to be delivered to the mortgagee; (3) to keep the buildings and all other improvements upon the premises in good repair and not to permit waste; and (4) not to use the premises for any illegal purpose.

In the event that the nurchaser shall fail to pay before delinquency any taxes or assessments or any pay-

In the event that the purchaser shall fail to pay before delinquency any taxes or assessments or any pay an the event that the purchaser shall tall to pay before deiniquency any taxes of assessments or any pay-ments required to be made on account of the mortgage, or to insure the premises as above provided, the seller may pay such taxes and assessments, make such payments, and effect such insurance, and the amounts paid therefor by him shall be deemed a part of the purchase price and become payable forthwith with intensit at the rate of 10 per cent per annum until paid, without prejudice to other rights of seller by reason of such failure.

OFFICE

The purchaser agrees to assume all risk of damage to any improvements upon the premises, or of the taking of any part of the property for public use; that no such damage or taking shall constitute a failure of the explication, but in case of such damage or taking, all moneys received by the seller by reason thereof shall salize may be required to expend in procuring such money, or at the election of the seller, to the rebuilding or restoration of such improvements.

The seller agrees, upon receiving full payment of the purchase price and interest in the manner above specified, to execute and deliver to purchaser a deed to the property,

excepting such part thereof which may hereafter be condemned, if any, free of incumbrances except those above mentioned, and any that may acrue hereafter through any person other than the seller.

The parties agree: (1) to execute all necessary instruments for the extension of payment or renewal of said mortgage during the period prior to the delivery of said deed, or the termination of purchaser's rights by gation or to execute any mortgage provided the seller shall not be obligated thereby to assume any personal oblinidebtedness in excess of that now unpaid on the above mentioned mortgage or bearing an interest rate of more full inspection of the real estate and that no promise, agreement or representation respecting the condition of any building or improvement thereon, or relating to the alteration or representation respecting the condition of tional improvements thereon, shall be binding unless the promise, agreement or representation be in writing and made a part of this contract; (3) that the purchaser shall have possession of the real estate on and be entitled to retain possession so long as purchaser is not in default

and be entitled to retain possession so long as purchaser is not in default registered mail to the address of the purchaser, or his assigns, last known to the seller,

Time is of the essence hereof, and in the event the purchaser shall fail to comply with or perform any condition or agreement hereof promptly at the time and in the manner herein required, the seller may elect to declare all of the purchaser's rights hereunder terminated, and upon his doing so, all payments made by the purchaser hereunder and all improvements placed upon the premises shall be forfeited to the seller as liquidated damages, and the seller shall have the right to re-enter and take possession of the property; and if the seller within six months after such forfeiture shall commence an action to procure an adjudication of the termination of the purchaser's rights hereunder, the purchaser agrees to pay the expense of searching the title for the purpose of such action, together with all costs and a reasonable attorney's fee.
