vey and warrant to HAROLD W. LARSON and ANITA T. LARSON, husband and wife, the fol-

lowing described real estate, situated in the County of Skamania, State of Washington:

That portion of the Southwest Quarter of the Southeast Quarter (SW4 SEL) of Section 25, Township 3 North, Range 7 E. W. M. lying Westerly of County Road No. 2062 designated as Kanaka Creek Road described as follows:
