in hand paid, conveys and warrants to JOSEPH M. AMSTADT and MARGARET AMSTADT, husband and wife,

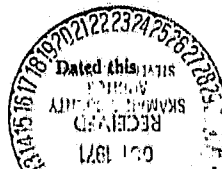
the following described real estate, situated in the County of Skamania, State of Washington:
