

## RIGHT OF WAY EASEMENT

THE GRANTOR(S) ... GORDON W. GOODE and RUTH M. GOODE, his wife

for good and valuable consideration, the receipt of which is hereby acknowledged, hereby grant, warrant and convey to PUBLIC UTILITY DISTRICT NO. 1 OF SKAMANIA COUNTY, WASHINGTON, a municipal corporation, and to its successors and sub-lessee or assigns, the right to enter upon the lands of the Grantor(s) situated in the County of Skamania, State of Washington, and more particularly described by the following instrument:

Five (5) feet in width along the route presently flagged upon the following described property located within the Southwest Quarter of the Northwest Quarter (SW<sub>1</sub> NW<sub>1</sub>) of Section 34, Township 2 North, Range 5, E.W.M.

Beginning at a point marking the intersection of the channel of the Washougal River with the West boundary line of the said Section 34; thence following the channel of the Washougal River Easterly to a point 600 feet East of the West line of the said Section 34, said point being the initial point of the tract hereby described; thence North 43° feet, more or less, to a point in the center of a certain private road as staked out and established on December 7, 1942; thence Easterly following the center of said private road to a point 655 feet East of the West line of said Section 34; thence South 23° feet; thence East 45 feet; thence South 205 feet, more or less, to the channel of the Washougal River, said point being 700 feet East of the West line of the said Section 34; thence Westerly following the channel of the Washougal River to the initial point

To construct, operate and maintain over and under the above described lands, and the streets, roads or highways abutting the said lands, an underground electric transmission or distribution line or system, including wires and conduit, with all convenient or necessary surface mounted appurtenances (and to include riser poles and transformer poles when required) and to cut and trim trees and shrubbery that may interfere with or endanger the operation and maintenance of said line or system, and to license, permit or otherwise agree to the joint use or occupancy of said line or system by other person, firm or corporation for telephone or television purposes.

The grantor(s) agree(s) that all poles, wires or other facilities installed upon or under the above described lands at the Grantee's expense shall remain the property of the Grantee, and that the Grantee shall have the right of ingress and egress over the adjacent lands of the Grantor(s) for the purpose of exercising the rights hereby granted.

All rights hereunder shall cease when the Grantee, its successors and sub-lessors or assigns abandon or removes said line or system.
