Statutory Warranty Deed

in hand paid, conveys and warrants to Skamania County, Washington

the following described real estate, situated in the County of Skamania, State of Washington: A right of way as required for the reconstruction of the County Road known and designated Maple Way Road, County Road No. 2060 in Section 36, Township 3 North, Range 7 E.W.M. in Skamania County, Washington more particularly described as follows:

PROPOSED CENTERLINE DESCRIPTION

Beginning at Sta. 3 + 65.47, an iron reinforcing bar in the intersection of Maple Way and Gropper Road, said point being N 87° 38' W, 668.00 ft. from the center of Section 36, Township 3 North, Range 7 E.W.M. Thence N 0° 06' W 812.29 ft. to P.C. Sta. 11 + 77.66. Thence on a 11° 30' curve to the left 711.88 ft. Thence 81° 58' W 457.02 ft. to P.C. Sta. 23 + 46.66. Thence on a 11° 30' curve to the right 725.94 ft. to P.T. Sta. 30 + 72.60.

Right of Way Description

1. A strip of land lying westerly of and contiguous to the above described centerline 40 ft. in width from Sta. 12 + 90 to Sta. 13 + 50; thence 30 ft. in width to Sta. 18 + 20.
2. A strip of land lying easterly of and contiguous to the above described centerline 30 ft. in width from Sta. 12 + 75 to Sta. 14 + 00.
3. A strip of land lying northerly of and contiguous to the above described centerline 40 ft. in width at Sta. 17 + 00 tapering to 70 ft. in width at Sta. 18 + 35.

The above described parcels containing a total of 0.63 acres less existing right of way for a total of 0.62 acres more or less.
