REAL ESTATE CONTRACT

THIS CONTRACT, made and entered into this

1st day of September, 1971,

THELMA I. TOMBLESON, who acquired title as THELMA I. MATHANY, dualing with her separate property, and GORDON D. TOMBLESON, her husband.

hereinafter called the "seller," and WINFIELD R. JONES and ALICE E. JONES, husband and wife,

hereinafter called the "purchaser,"

WITHING That the seller agrees to sell to the purchaser and the purchaser agrees to purchase from the seller the following described real estate, with the appurtenances, in Skamania County, State of Washington:

All that portion of Government Lot 3 of Section 36, Township 3 North, Range 8 E. W. M. lying easterly of the center line of County Road No. 3243 designated as the Girl Scout Road and easterly of the center line of County Road No. 3040 designated as the Bergen Road from its point of intersection with said Girl Scout Road southerly to the south line of said Government Lot 8; EXCEPT that portion thereof conveyed to James H. Rike and Nellie I. Rike, husband and wife, by deed dated February 2, 1961, and recorded February 6, 1961, at page 305 of Book 48 of Deeds, under Auditor's File No. 58085, Records of Skamania County, Washington.

The terms and conditions of this contract are as follows: The purchase price is Seven Thousand Five Hundred - (\$ 7,500.00 - (\$ 3.000) Dollars, of which and no/100ths -3,000.00 Three Thousand and no/100ths been paid, the receipt whereof is hereby acknowledged, and the balance of said purchase price shall be paid as follows;

The purchasers agree to pay the remaining balance of the purchase price amounting to Four Thousand Five Hundred and no/100ths (\$4,500.00) Dollars in quarterly installments of Two Hundred Seventy-five and no/100ths (\$275.00) Dollars, or more, commencing on the 1st day of December, 1971, and on the 1st day of each March, June, September and December thereafter until the full amount of the purchase price together with interest shall have been paid. The said quarterly installments shall include interest at the rate of six per-cent (6%) per annum computed upon the quarterly balances of the unpaid purchase price, and shall be applied first to interest and then to principal. The purchasers reserve the right at any time they are not in default under the terms and conditions of this contract to pay without penalty any part or all of the unpaid purchase price, plus interest then due. Purchasers agree neither to cut nor remove any merchantable timber without the written consent of the sellers until the unpaid purchase price shall have been reduced to \$3,500.00.

(4) The purchaser assumes all hazards of damage to or destruction of any improvements now on said real estate or itereafter placed thereon, and of the taking of said real estate or ary part thereof for public use; and agrees that no such damage, destruction or taking shall constitute a failure of consideration. In case also part of said real estate is taken for public use, the portion of the condemnation award remaining after paymint of reasonable expenses of procuring the same shall be paid to the seller and applied as payment on the purchase piece herein unless the keller elects to allow the ruchastr to apply all or a portion of such condemnation award to the rebuilding or resturation of any improvements damaged by such taking, it case of damage or destruction from a peril insured against, the proceeds of such improvements within a reasonable time, unless purchaser elects that said proceeds shall be paid to the seller for application on the purchase price herein.

(5) The totale has addivered, or agrees to deliver within 15 days of the date of dealers a michaestral action of this tenument.

(5) The seller has delivered, or agrees to deliver within 15 days of the date of closing, a purchaser's policy of title insurance in standard form, of a cummitment therefor, issued by Transomerico Tille Insurance Company, insuring the purchaser to the full amount of said purchase price against loss or damage by reason of defect in seller's title to said real estate as of the date of closing and containing no exceptions other than the following:

a. Printed general exceptions appearing in said policy form;

b. Lifens or encumbrances which by the terms of this contract the purchaser is to assume, or as to which the conveyance hereunder is to be made subject; and

Any existing contract or contracts under which seller is purchasing said real estate, and any mortgage or other obligation, which seller by this contract agrees to pay, none of which for the purpose of this paragraph (5) shall be deemed defects in seller's title.

(6) If seller's title to said real estate is subject to an existing contract or contracts under which seller is purchasing said real estate, or any mortgage or other obligation, which seller is to pay, seller agrees to make such payments in accordance with the terms thereof, and upon default, the purchaser shall have the right to make any payments necessary to remove the infault, and any payments so made shall be applied to the payments next falling due the seller under this contract.

(7) The seller agrees, upon receiving full payment of the purchase price and interest at the manner above specified, to execute and

deliver to purchaser a statutory warranty deed to said real estate, excepting any part thereof hereafter taken for public use, free of encumbrances except any that may attach after date of closing through any person other than the seller, and subject to the following:

(a) Easements and rights of way for public roads.

(8) Unless a different date is provided for herein, the purchaser shall be entitled to possession of said real estate on date of closing and to retain possession so long as purchaser is not in default hirrounder. The purchaser covenants to keep the buildings and other improvements on said real estate in good repair and not to permit waste and not to use, or permit the use of, the real estate for any illegal purpose. The purchaser covenants to pay all service, installation or construction charges for water, sewer, electricity, garbage or other utility services furnished to said real estate after the date purchaser is entitled to possession.

(9) In case the purchaser fails to make any payment herein provided or to maintain insurance, as herein required, the such payment or effect such insurance, and any amounts so paid by the seller, together with interest at the rate of 40% per annum thereon from date of payment utail repaid, shall be repayable by purchaser on seller's demand, all without prejudice to any other right the seller might have by reason of such default.
