

EASEMENT SUPPLEMENT

THIS SUPPLEMENTAL AGREEMENT, made and entered into this 7th day of September, 19 71, by and between WEYERHAEUSER COMPANY, a Washington corporation, herein called "Weyerhaeuser," and STATE OF WASHINGTON, acting by and through the Department of Natural Resources, herein called "State," WITNESSETH:

Whereas, on the 18th day of August, 1969, Weyerhaeuser and the State entered into an easement exchange hereinafter called Original Easement, which was recorded in the records of Skamania County, Washington on the 5th day of September, 1969, in Volume 61 of Deeds, pages 155 - 161 under Auditor's File No. 71351. Said Original Easement is hereby supplemented as follows:

I

A. State, for and in consideration of Two Hundred and No/100 Dollars (\$200.00) for damages, hereby grants and conveys to Weyerhaeuser, its successors and assigns, a permanent easement assignable in whole or in part upon, over, and along rights of way variable feet in width as shown on the attached Exhibit A over and across SE 1/4, Section 23, Township 7 North, Range 5 East, W.M., in Skamania County, Washington, being twenty (20) and thirty five (35) feet on each side of the center line(s) of a road or roads located approximately as shown in green on the attached "Exhibit A."

Subject as to said lands to all matters of public record.

Except as herein supplemented all of the terms, conditions and reservations of the Original Easement shall remain in full force and effect.
