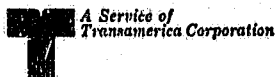

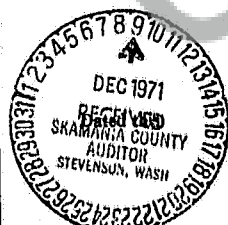
RESERVING to the grantor the right to use and occupy the existing dwelling house on said premises for the duration of her natural life;
