AMENDED REAL ESTATE CONTRACT

"The terms and conditions of this contract are as fol-"The terms and conditions of this contract are as follows: The purchase price is Two Thousand Two Hundred Fifty and no/100 Dollars (\$2,250.00), of which Three Hundred Dollars (\$300.00) have been paid, the receipt of which is hereby acknowledge, and the balance of said purchase price shall be paid as follows: The sum of Forty-Five Dollars (\$45.00) shall be paid on or before the 5th day of October, 1971, and like payments shall be made on the 5th day of each and every month thereafter for a period of thirty-five (35) months. It is agreed that on the 36th month the entire balance of unpaid principal and interest is to be paid in full. The unpaid principal balance is to bear interest at the rate of eight per cent (8%) per cent per annum and each rate of eight per cent (8%) per cent per annum and each monthly payment referred to herein shall include such interest."

Except as herein modified, said Real Estate Contract is hereby affirmed in its entirety.


