WITNESSETH: The seller agrees to sell to the purchaser, and the purchaser agrees to purchase of the

On the following terms and conditions: The purchase price is Three Thousand and no/100ths (\$3,000.00) dollars, of which has been paid, the receipt whereof is hereby acknowledged, and the purchaser agrees to pay the balance of said purchase price as follows:

The purchaser agrees to pay the balance of the purchase price in the sum of Two Thousand Five Hundred Sixty-five and no/100ths (\$2,55.00) Dollars in monthly installments of Twenty-five and no/100ths (\$25.00) Dollars of the purchase of each and every month thereafter until the full amount of the purchase price together with interest shall have been paid. The said monthly installments shall include interest at the rate of six per-cent (6%) per annum computed upon the monthly balances of the unpaid purchase price, and shall be applied first to interest and then to principal. The purchaser reserves the right at any time that he is not in default under the terms and conditions of this contract to pay without penalty any part or all of the unpaid purchase price, plus interest then due.
