Purchaser hereby grants the owner's of property (their heirs and/or assigns) bordering the Morth and West sides of subject property a 60 foot wide easement for road and utility purposes, providing that they shall grant to purchaser, his heirs and assigns the right to utilize said easement from subject property to public roads.
