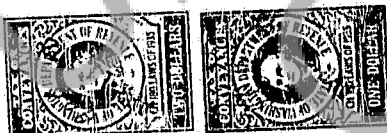

A tract of land located in Government Lot 4 of Section 8, Township 3 North, Range 8 E. W. M., described as follows:

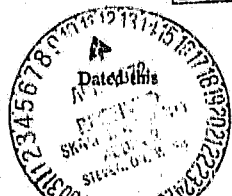
