part of the second part:

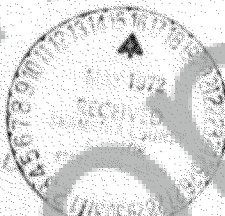
Witnesseth, That the said part of the first part, for and in consideration of the sum of Five Thousand One Hundred and 00/100 DOLLARS lawful money of the United States, to in hand paid by the said part of the second part, the receipt whereof is hereby acknowledged, do by these presents, grant, bargain, sell, convey and confirm unto the said part of the second part, and to their heirs and assigns, the following tract, lot or parcel of land, situate, lying and being in the County of Skamania, State of Washington, and particularly bounded and described as follows, to-wit:

beginning at a point in the center of a 40 foot section front known as Burns Road which is 1710.77 feet north and 1122.33 feet west of the section corner of S 34, T1, R2E, Town 12 North, Range 2 East of the Willamette Meridian; thence south 89°35' west 25.19 feet along the center of Burns Road to the S. 34 section corner; thence south 89°35' west 124.75 feet along the center of Burns Road; thence north 0°19' west 322.12 feet more or less, to the corner of the section of the Skamania River; thence north 28° west 130.22 feet; thence south 89°35' west 450 feet, more or less, to the point of beginning. Section One here more or less will in the north 1/2 of the Southeast 1/4 of section 24 Township 2 North, Range 2 East of the Willamette Meridian, except Burns Road.

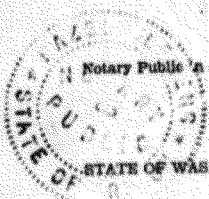
