DECREE OF DIVORCE

This matter came on for hearing before the above
entitled Court this 15th day of December, 1971 upon the petition and
application of the plaintiff, plaintiff not appearing in person and
by one of her attorneys, Esq. J. Carver; the defendant appearing in
person and being in default and his default having been heretofore made and
entered herein as set forth; it now appearing to the Court that
the Complaint of the plaintiff has been on file in this Court in
this action for more than ninety days and that service of summons
and complaint on the defendant has been made within ninety days
prior to the date of this hearing; the State of Washington set ap-
pearing by and through the duly and regularly elected, qualified and acting
Deputy Prosecuting Attorney of Clark County, State of Washington, the
Court proceeded to hear and consider the testimony and evidence of
the plaintiff and having heard and considered the same and the records
and files hereto and having heretofore made and entered herein its
findings of fact and conclusions of law, its written and unobjection
being made by the said Prosecuting Attorney to the entry of a decree
in this action:

IT IS HEREBY ORDERED, ADJUDGED AND DECREED:

1. That the bonds of matrimony now and heretofore exist

1 ing between MERLE M. CLARK, plaintiff, and JO D. CLARK, defendant,
 2 be and the same are hereby set aside and canceled and the plaintiff
 3 is divorced from the defendant;

4 2. That the plaintiff be and she is hereby awarded
 5 as her sole and separate property the real property located in
 6 Skamania County, State of Washington described as follows:

7 Family home

8 Lot 7 of Meaghers Addition to Stevenson
 9 according to the re-plat thereof on file
 10 and of record at page 120 of Book "A" of
 11 Plats, records of Skamania County, Washington.

12 Lot

13 A tract of land located in the Southeast
 14 Quarter of the Southwest Quarter (SE 1/4
 15 SW 1/4) of Section 36, Township 3 North,
 16 Range 7 E.W.M. described as follows:

17 Beginning at the quarter corner on the south
 18 line of the said Section 36; thence west
 19 along said south line 289.7 feet; thence north
 20 $05^{\circ}30'$ west 465.4 feet to the initial point of
 21 the tract hereby described; thence north 05°
 22 $30'$ west 40 feet; thence south 72° east 100
 23 feet; thence north 223.57 feet to the north
 24 line of a tract of land conveyed to Mabel J.
 25 Jeter by deed dated April 4, 1947, recorded
 26 under Auditor's File No. 36513 at page 342
 27 of Book 31 of Deeds, Records of Skamania County,
 28 Washington; thence west 130.66 feet to the brow
 29 of Rock Creek Canyon; thence in a southerly
 30 direction following the brow of said canyon to

 34 and her personal clothing and effects as well as the property in
 35 Oregon, which she acquired prior to this marriage; that the plaintiff
 36 shall assume and pay the mortgage upon the real property in the State

38 3. That defendant be and he is hereby awarded as his
 39 sole and separate property the 1966 Ford pickup and his personal
 40 belongings and effects;

41 4. That the former name of the plaintiff, Merle M. Corey,
 42 be and the same is hereby restored to her;

5. That the defendant be and he is hereby ordered and directed to pay all outstanding community indebtednesses of the parties as of August, 1971 except as provided for above;

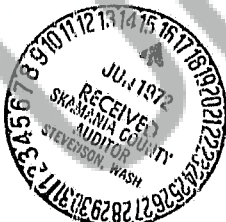
6. That the plaintiff be and she is hereby awarded \$350.00 as attorneys fees in this action together with costs in the amount of \$27.20.
