That portion of the Elizabeth Snooks U. L. C. and of Government Lot 13 in Section 25, Township 2 North, Range 6 E. W. M., described as follows:

Beginning at the northeast corner of the said Snooks U. L. C., said point also being the southeast corner of said Government Lot 13; thence north to the northeast corner of said Government Lot 13; thence along the north line of said Government Lot 13 west 660 feet; thence south to the south line of said Government Lot 13; thence along the south line of said Government Lot 13 north 89° 56' east to a point 554 feet distant from the point of beginning; thence south 42° 43' east to a point on the northerly right of way line of Primary State Highway No. 8; thence following the northerly right of way line of said highway northeasterly to intersection with the east line of the said Snooks U.
