

The Grantor, PORTLAND AREA COUNCIL OF CAMP FIRE GIRLS, an Oregon non-profit corporation, for and in consideration of One Dollar (\$1.00) and other valuable consideration, in hand paid, receipt of which is hereby acknowledged, grants and conveys to the State of Washington, acting by and through its Department of Natural Resources, Grantee, its successors and assigns, an easement for road right of way 60 feet in width over and across the following described lands in Skamania County, Washington, to wit:

N $\frac{1}{4}$ Section 9, and NE $\frac{1}{4}$ NE $\frac{1}{4}$ Section 7, Township 2 North, Range 5 East, W.M.

as shown in red on the plat marked Exhibit A, which is attached hereto and by this reference made a part hereof.

The easement granted herein is subject to the following terms and conditions:

1. The road to be constructed and/or maintained on the said right of way shall be used for access to lands presently or in the future owned or controlled by the Grantee for land management and administration activities, including but not limited to valuable material removal operations, and for public access to such lands for recreational purposes under such rules, regulations, and limitations as may be established by Grantee.
2. The Grantor reserves to itself, its successors and assigns, the right to use, at its own risk, the roadway in any manner which does not unreasonably interfere with the use of said road by the Grantee, its successors and assigns, agents, contractors, employees, or licensees, or the public when on said road in conformity with the rules, regulations, and limitations referred to in Condition 1 above.
3. It is understood and agreed that this easement supersedes and terminates that easement dated September 12, 1961, granted by Portland Area Council of Camp Fire Girls, to State, as recorded in Volume 49, Pages 263-285 under Auditor's File 59189.




RIGHT OF WAY PLAT


