WITNESSETH: The seller agrees to sell to the purchaser, and the purchaser agrees to purchase of the

The purchasers agree to pay the balance of the purchase price in the sum of Four Thousand Four Hundred Twenty-five and no/100ths (\$4,425.00) hollars in monthly installments of Seventy-five and no/100ths (\$75.00) Dollars, or more, commancing on the 1st day of September, 1972, and on the 1st day of each month thereafter until the full amount of the purchase price togethor with interest shall have been paid. The said monthly installments shall include interest at the rate of eight percent (8%) per annum nomputed upon the monthly balances of the unpaid purchase price, and shall be applied first to interest and then to principal. The property has been carefully inspected by the purchaser, and no agreements or representations pertaining thereto, or to this transaction, have been made, save such as are stated herein.

The purchaser agrees; to pay before delinquency all taxes and assessments assumed by him, if any, and any which may, as between grantor and grantoe, hereafter become a lien on the premises; not to permit waste; and not to use the premises for any illegal purpose. If the purchaser shall fail to pay before delinquency any such taxes or assessments, the seller may pay them, and the amounts so paid shall be deemed part of the purchase price and be payable forthwith with interest at the rate of ten per cent per annum until paid, without prejudice to any other right of the seller by reason of such failure.

The purchaser assumes all risk of the taking of any part of the property for a public use, and agrees that any such taking shall not constitute a failure of consideration, but all cooneys received by the seller by reason thereof shall be applied as a payment on account of the purchase price, was any sums which the seller may be required to expend in procuring such impreys.

If seller's title to said real extate is subject to an existing contract or contracts under which seller is purchasing said real estate, or any mortgage or other obligation, which seller is to pay, seller agrees to make such payments in accordance with the terms thereof, and upon default, the purchaser shall have the right to make any payment necessary to remove the default, and any payments so made shall be applied to the payments next falling due the seller under this contract.

The seller agrees to furnish a Transamerica Fitle Insurance Company standard term purchaser's title policy when the purchaser shall have said the purchase price in full insuring the title to said property with liability the same as the above purchase price, free from incumbrances except any which are assumed by the purchaser or as to which the conveyance hereunder is not to be subject.

Time is of the essence hereof, and in the event the purchaser shall fail to comply with or perform any condition or agreement hereof prompilly at the time and in the manner herein required, the seller nidy elect to exclare all of the purchaser's rights hereunder terminated. Upon the termination of the purchaser's rights, an payments made hereunder, and all improvements placed upon the premises shall be forfeited to the seller as liquidated damages, and the seller shall have the right to re-enter and take possession of the property; and if the seller after such forfeiture shall commence an action to procure an adjudication of the termination of the purchaser's rights hereunder, the purchaser agrees to pay the expense of searching the title for the purpose of such action, together with all costs and a reasonable attorney's fee. such action, together with all costs and a reasonable attorney's fee.
