We, the undersigned, being the owners of the property herein described, do, in consideration of the benefits and advantages to accrue to us by the location and establishment of the above proposed County Road, hereby consent that said road be established as described in the petition herein and as examined and surveyed, and forever relinquish to Skamania County, Washington, a Right-of-Way variable feet in width over and across the following described piece or parcel of land, to-wit:

That parcel of land described in Deed dated July 16, 1953 and recorded at Page 36, Book 40 of Book of Deed in the Office of Skamania County Auditor

RIGHT OF WAY DESCRIPTION

A right of way as required for the reconstruction of the County Road known and designated Trout Creek Road (Co. Road No. 2270) located in Section 26, Township 4 North, Range 7 E. W. M. in Skamania County, Washington.

Centerline Description

Beginning at Sta. 20 + 00, said station lying South 2,412.72 ft. and West 747.68 ft. from the North one-quarter corner of Section 26, Township 4 North, Range 7 E. W. M. Thence S 1° 59' W 300.26 ft. to the P.C. of a 600 ft. radius curve to the right; thence following said curve 349.51 ft. to P.T. Sta. 26 + 49.77; thence S. 35° 21' 30" W 505.20 ft. to the P.C. of a 1,500 ft. radius curve to the left; thence following said curve 317.03 ft. to P.T. Sta. 34 + 72.00; thence S 23° 15' W 170.08 ft. to the South line of the N.W. 1/4 of the S.W. 1/4 of Section 26.


Right of Way Description

variable A strip of land 40 ft. in width lying 30 ft. on the left and 30 ft. on the right of above described centerline from Sta. 20 + 00 to Sta. 22 + 50; thence 35 ft. on the left and 30 ft. on the right from Sta. 22 + 50 to Sta. 23 + 50; thence 30 ft. on the left and 30 ft. on the right from Sta. 23 + 50 to Sta. 26 + 00; thence 35 ft. on the left and 35 ft. on the right from Sta. 26 + 00 to Sta. 28 + 50; thence 30 ft. on the left and 30 ft. on the right from Sta. 28 + 50 to Sta. 33 + 00; thence 35 ft. on the left and 35 ft. on the right from Sta. 33 + 00 to Sta. 35 + 00; thence 30 ft. on the left and 30 ft. on the right from Sta. 35 + 00 to Sta. 36 + 42.08 being the South line of the N.W. 1/4 of the S.W. 1/4 of Section 26, Township 4 North, Range 7 E. W. M.

and waive all claims for damages of whatever kind which may be occasioned to said land or any portion of the same, by examining, surveying, laying out and establishing said Road.

Giving and granting unto said Skamania County, Washington, the said Right-of-Way, with full power and authority to examine, survey, lay out and establish said Road as proposed, and to perpetually maintain the same as a County Road.
