the following described real estate, situated in the County of Skamania, State of Washington:

Beginning at a point on the south line, and 286.62 feet east of the south-west corner, of the Northeast Quarter (NE $\frac{1}{4}$) of Section 36, Township 3 North, Range 7 E. W. M.; thence north 27° 52' west a distance of 322.7 feet to intersection with the north line of the Henry Shepard D. L. C. extended west; thence east 384.5 feet; thence south 15° 10' east to a point which is 120 feet north 15° 10' west of the northerly line of the county road known and designated as the Ziegler Road as the same was constructed and existed on June 19, 1951, said point being the initial point of the tract hereby described; thence easterly parallel to the northerly line of the said road as then constructed 96 feet; thence south 15° 10' east 120 feet to the northerly line of the said Ziegler Road; thence westerly following the northerly line of the said road 96 feet; thence north 15° 10' west 120 feet to the initial point;
