The Grantor, William J. Wineberg, individually and as Executor of the Estate of Janet R. Wineberg, deceased, for and in consideration of the sum of \$10.00 and other valuable consideration, receipt of which is hereby acknowledged, conveys and warrants to Chateau Properties, Inc., a Washington corporation, the following described real estate situated in Skamania County, Washington, to-wit:

The South Half of the Northeast Quarter (S $\frac{1}{2}$  NE $\frac{1}{4}$ ), and the Northwest Quarter of the Southeast Quarter (NW $\frac{1}{4}$  SE $\frac{1}{4}$ ), of Section 5, Township 1 North, Range 5 East, W.M.;

Excepting therefrom the following:

1. Easements and rights of way for electric power transmission lines granted to Northwestern Electric Company, a Washington corporation, by deeds dated July 29, 1930, and June 9, 1930, and recorded September 24, 1930, respectively, at pages 471 and 476 of Book W of Deeds, Records of Skamania County, Washington; and

2. A strip of land of variable width granted to the state of Washington for a right of way for Secondary State Highway No. 6-B by deed dated November 29, 1937, and recorded December 23, 1937, under Auditor's File No. 85106 at page 529 of Book Z of Deeds, Records of Skamania County, Washington; and

3. Lot 1 of Block 3 of Brindle Park Estates, according to the official plat thereof on file and of record at page 131, Book A of Plats, Records of Skamania County, Washington, which was heretofore conveyed by partial fulfillment deed dated August 10, 1967; and

4. Lots 1, 2, 3, 4 and 5, Block 1, Lots 1, 2, 3 and 4 of Block 2, Brindle Park Estate, also known as the south one-half of the Northeast Quarter, Section 5, Township 1 North, Range 5 East, W.M., lying northerly and easterly of the County Road therein, which was heretofore conveyed by partial fulfillment deed dated February 28, 1970.
