# RIGHT OF WAY AND EASEMENT AMENDMENT

WHEREAS, by that certain Right of Way Contract dated November 29, 1955 recorded in the Records of Skamania County, Washington, in Book 40, Page 486, Vina D. Holman, as Grantor, granted and conveyed unto Pacific Northwest Pipeline Corporation, a Delaware corporation, its successors and assigns a right of way and easement to construct, maintain and operate a pipeline or pipelines on a right of way over and across the following described lands situated in Skamania County, Washington to wit:

SE 1/4, Section 32, Township 2 North,  
Range 6 East, W.M.

WHEREAS, El Paso Natural Gas Company, a Delaware corporation, hereinafter referred to as Grantee, is the successor in interest to Pacific Northwest Pipeline Corporation, and;

WHEREAS, the undersigned Grantor is now the owner of the above described property and;

WHEREAS, the Grantor and Grantee desire to and have agreed to amend said Right of Way Contract.

NOW THEREFORE, for and in consideration of Ten Dollars (\$10.00) and other consideration paid to the Grantor by the Grantee herein, the receipt of which is hereby acknowledged, the Grantor and Grantee do hereby amend said Right of Way Contract to provide as follows:

The right of way and easement over and across the property described above shall henceforth be more particularly described as follows:

A strip of land 75 feet wide, being 20 feet southerly of and 55 feet northerly of a survey line across the southeast quarter northeast quarter Section 32, Township 2 North, Range 6 East, W.M., Skamania County, Washington, the survey line being more particularly described as follows:

Beginning at a point on the East boundary of said southeast quarter northeast quarter Section 32, said point bears South 53°19' West, a distance of 3464.1 feet from a brass cap for the North quarter corner of Section 33, said Township and Range; thence South 69°08' West, a distance of 1410 feet to a point on the South boundary of said southeast quarter northeast quarter Section 32, said point bears South 57°53' West, a distance of 4836.1 feet from said North quarter corner of said Section 33.

Said Right of Way Contract, as hereby amended, shall be binding upon parties hereto, their heirs, successors and assigns.
