## WITNESSETA:

That for are in consideration of the mutual love and affection that each of the parties has for the other, and in consideration of the mutual benefits to be derived by the parties hereto, it is hereby agreed, covenanted and promised as follows:

That all of the property of character nature or kind or description, whether real or personal or mixed, and wheresoever situated ,now owned or hereafter acquired by them or either of them, shall be considered and is hereby declared to be the community property of the parties. That the real estate now so covered hereby is particularly described as follows:

Beginning at the woutheast corner of the Northeast Quarter of the Southwest Quarter of Section 26, Township 4 North, Range 9 E.N.M., thence West 346.1 feet to the center of the county road; thence along the center of the said county road in a northwesterly direction 332.49 feet to the initial point of the tract hereby described; thence in a southerly direction along the center line of said county road to a point which is South 208 feet from a line drawn east and west through the initial point; thence East 208 feet; thence North 208 feet; thence West to the point of beginning.
